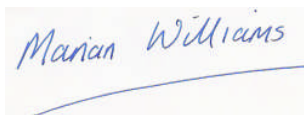


ANNUAL GENERAL MEETING

The business of the AGM shall be in accordance with rule 11.1 & 11.2 of the league's constitution.

For clarification, all motions, including nominations for Officers or the Management Group, submitted by Clubs or Composite Teams must be sent in writing to the league administrator by 21st October 2017 at the latest. They must be submitted on club headed notepaper signed by two officers of the Club, or the YDL representative and one other officer of the Club, with the agreement of the Club's Management Committee.

Motions must be supported by at least 5 additional Clubs or Composite teams. (Composite teams are considered to be one club, and any resolutions must have the agreement of all members of the composite.)

There will be an open forum meeting prior to the AGM to discuss the returns of the composite teams' questionnaire. This meeting will convene at 10:30 for a 10:45 start and will aim to finish by 11:45.

Template for motions submitted to the AGM

Every motion including nominations for Officers or the Management Group, to be placed on the Agenda must be sent in writing to the Administrator at least 28 days before the date of the meeting (ie 22nd October 2016). All such motions must be signed by at least six Clubs or Composite Teams.

Any motions must be on club headed notepaper signed by any two Officers of the Club (or the YDL representative and one other Officer of the Club) and must have the agreement of the Club's Management Committee.

Composite teams are considered to be one Club and any resolutions from a Composite team must be signed by any two representatives of that Composite team one of whom may be its YDL representative, but must have the agreement of the majority of the members of that Composite.

Clubs may if they wish use the attached template as a guide. (Clubs who intend to submit a motion can circulate this form to all supporting clubs and ask that they sign in the appropriate places and return to the proposing club who will then forward all documentation onto the Administrator).
